# 2007-08-07 PRESENTATION - State Highway 165 Bypass Project

Development Services Director Robert Lewis states numerous county staff attended a citizen's advisory committee meeting concerning the Highway 165 Bypass and reviews future steps in the process.

Public Works Director Paul Fillebrown reviews a map depicting the project site and states the consultants are considering a single growth scenario in the communities of Hilmar and Delhi. He states staff believes it is important to look at a model that would consider the impacts if all of the area projects were ultimately approved, along with the growth contemplated in Delhi and Hilmar.

Supervisor Kelsey states the policy committee adopted two scenarios: the first one includes all known growth inside the Specific Urban Development Plans as expanded over the next 25 years and the second scenario is the amount in the first scenario plus three percent.

Merced County Association of Governments Executive Director Jesse Brown states this is a very complex process and is typically done in a single county but this project goes across county lines dealing with five different agencies, two different councils of government which will require more time to complete.

Supervisor Kelsey states this presentation will be provided in the Delhi, Hilmar and Stevinson areas and other presentation(s) will be provided as the project progresses.
