# 2012-05-08 COMMERCE, AVIATION, AND ECONOMIC DEVELOPMENT - BID OPENING

The Clerk announces the Bid Opening for the sale of Building 1323 including 0.3 acres of land within Castle Commerce Center is before the Board for consideration.

Commerce, Aviation, and Economic Development Director Mark Hendrickson walks the Board through the bid process requirements and states that a private sector organization has expressed interest in acquiring the property from the county for their own business interest; however, the process must be followed as required by law.

The Chairman states a bid has been received with Intent to Purchase, including the requisite check. The Chairman asks if there is anyone in the audience wishing to submit an oral bid within the requirements as prescribed by law. There are no oral bids. The bid is given to Mr. Hendrickson to make copies for the Board's review. The Board will revisit this item at the end of the agenda at which time the Board will take a brief recess to review the bid and make a decision regarding direction.

The Board recesses at 11:30 a.m. to review the bid submitted by West Coast Gas, Inc. to purchase Building 1323 located within Castle Commerce Center.

The Board reconvenes at 11:40, and the Chairman informs that the bid for Building 1323 has been reviewed and it is reflective of what the County is asking for, and requests that Mark Hendrickson provide information pertaining to the completeness and responsiveness.

Commerce, Aviation, and Economic Development Director Mark Hendrickson states that the bid is from West Coast Gas, Inc., the offer is for \$217,637 which includes \$87,000 in a cash contribution, and \$130,637 in improvements to be made within the next six months. The offer also includes the required \$20,000 cash deposit. Mr. Hendrickson reviews the improvements to be made by West Coast Gas, Inc. as submitted in writing and included with the bid. He further states that copies of the bid package are available for the public, and staff believes that the proposal meets and conforms to the Resolution adopted by the Board on April 3, 2012. Mr. Hendrickson recommends that the Board accept the proposal and adopt the Resolution accepting the proposal.

# 2012-05-08 PRESENTATION – Budget

County Executive Officer James Brown informs the Board that today's presentation is a brief update on where we stand at the end of the 3<sup>rd</sup> quarter and impacts of what we are looking at for next year. Mr. Brown states that Proposed Budget is scheduled for the end of June with the Final Budget hearing at the end of August. Mr. Brown and Assistant Executive Officer Scott DeMoss provide a power point presentation on the County Budget and review the following: General fund Revenue vs. Expenditures 3<sup>rd</sup> Quarter, Revenues vs. Expenditures, (General Fund), General Fund Cash Flow Comparison, Net County Costs, Budget Overview, and Net County Cost by Area. County Executive Officer James Brown states the bottom line is that there is a \$13 to \$14 million dollar shortfall for next year. They will be presenting the Board with a Proposed Budget at the end of June for consideration and Final Budget in August. Mr. Brown states that the total budget is \$436 million, General Fund is only \$342 with about \$90+ million in Other Funds, Net County is at \$86 million funded by \$62 million in Revenue with a Fund Balance of \$23.9 million. They are planning on a Fund Balance number to be about a \$17 million number, revenues at about \$64 million, to get at the \$81 million number to use as a target to drop costs for next year.

County Executive Officer James Brown states everyone will need to work together to participate at the "table" to structure a budget.
