2014-04-08 COMMUNITY AND ECONOMIC DEVELOPMENT – PUBLIC HEARING

The time and date previously set for a public hearing to consider the Planning Commission's recommended approval of Conditional Use Permit No. CUP13-009 – Sun Harvest Solar LLC as submitted by Community and Economic Development.

Community and Economic Development Director Mark Hendrickson provides a staff report and summarizes information regarding the project as outlined on the Board Agenda Item. Mr. Hendrickson states this item is before the Board because only the Board may remove the project site from the Williamson Act Agricultural Preserve and notes that the site is not under Williamson Act contract.

The Chairman opens the public hearing and asks if there is anyone present wishing to speak.

Concerned citizen speaks in opposition to this project and questions how the project site can be removed from the Williamson Act and approve mitigation monitoring, and she questions funding.

The Chairman suggests concerned citizen speak to Community and Economic Development Director Mark Hendrickson.

Community and Economic Development Director Mark Hendrickson responds to concerned citizen's statements and states that this is a solar project on 11 acres of property that is privately owned and within the Williamson Act Preserve but not under contract. He further states that there is no funding involved, but it is required that the Board remove the site from the Williamson Act Preserve prior to project approval.

The Chairman closes the public hearing.

Upon motion of Supervisor Pedrozo, seconded by Supervisor Davis, duly carried, the Board adopts the Initial Study/Mitigated Negative declaration and Conditional use Permit No. CUP13-009 based on the 11 findings and subject to the 15 conditions of approval and 5 mitigation measures as follows:

Project Findings:

- Conditional Use Permit No. CUP13-009 for the Sun Harvest Solar LLC (NDP1)
 Project proposes to construct a 1.5 megawatt (mw) alternating current (AC)
 photovoltaic (PV) energy generation facility on 11 acres of two parcels totaling 40
 acres.
- The project site is located on the east side of San Juan Road, 550 feet north of Highway 152 in the Dos Palos area.
- The project is consistent with the Agricultural land use designation and with the Merced County 2030 General Plan, specifically; the Land Use Element, the Transportation Circulation Element, the Health and Safety Element, the Natural Resources Element, and Agriculture Element.
- Removal of 11 acres from the Merced County Williamson Act Agricultural Preserve is appropriate as the Sun Harvest Solar Energy Project will not compromise the longterm agricultural capability of the project site and adjacent agricultural lands.
- With implementation of the CEQA Mitigation Measures and Conditions of Approval, the project will not impact County roads or facilities.
- The project as conditioned is compatible with adjacent uses, properties and neighborhoods.
- 7. The public hearing has been adequately noticed and advertised.
- 8. The Zoning Code allows an energy generation facility in the A-1 (General Agricultural) zone with the review and approval of a Conditional Use Permit.

- 9. The project is also in compliance with all development standards in the A-1 zone.
- The proposed use, if operated in compliance with all requirements and conditions, will not be a nuisance or detrimental to the public health, safety, or general welfare.
- 11. The application and Initial Study was referred to the following county agencies for review: Public Works/Building & Safety Division, Division of Environmental Health, Fire Department, and the Department of Public Works/Roads Division. The application was also referred to Caltrans- District 10, California Department of Fish and Wildlife, Regional Water Quality Control, United States Department of Fish and Wildlife Los Banos, San Joaquin Valley Air Pollution Control District, Pacific Gas & Electric, Native American Heritage Commission, and property owners within 300 feet of the project site. All comments were adequately addressed in the Staff Report and Initial Study.

Conditions of Approval

Planning and Community Development Department

- Conditional Use Permit No. CUP13-009 is granted for the construction of a 1.5 megawatt solar photovoltaic electrical generating facility on a 11 acres of two parcels totaling 40 acres located on the east side of San Juan Road, 550 feet north of Highway 152 in the Dos Palos area, in accordance with the approved Plot Plan and Operational Statement.
- 2. The solar photovoltaic electrical generating facility and project shall be located, developed and operated in a manner described on the approved Plot Plan, Project Description, CEQA Mitigation Measures, Mitigation Monitoring and Reporting Program, and Conditions of Approval of this permit. The operation of this facility shall cease no later than 30 years from the Commercial Operation Date. Any subsequent changes must be made in accordance with Merced County Code section 18.50.
- All CEQA Mitigation Measures identified in the Mitigation Monitoring and Reporting Program are adopted and incorporated by reference as Project Conditions of Approval.
- 4. The project shall comply with all applicable public health, safety, and welfare regulations administered by the County of Merced, and in particular the County Fire Department, the Health Department/ Environmental Health Division, the Community and Economic Development Department, and Public Works Department/ Road and Building and Safety Divisions.
- 5. For the purpose of conditions monitoring, an inspection fee in the amount of \$648.00 shall be required. This fee shall be paid within 30 days of the approval date. Should additional inspections be required, inspection time shall be billed to the applicant/property owner at the established hourly rate at the time of the inspection. This permit will not be considered valid until the conditions monitoring fee has been paid.

- Prior to issuance of a building permit, the project applicant must obtain all necessary permits and written authorizations and must demonstrate compliance with all applicable regulations administered by Federal and State agencies.
- 7. Immediately following the cessation of Project business operations or the abandonment of the Project, the applicant shall reclaim the site to pre-project conditions. Prior to the issuance of the first occupancy permit, the applicant shall place a financial assurance (bond, letter of credit, or similar instrument) dedicated specifically for the project to the benefit of Merced County. The County and Sun Harvest Solar, LLC will determine an appropriate amount for the financial assurance instrument. It is the intent of this requirement that the instrument shall provide sufficient financial assurances for Merced County to decommission the Project and fully restore the property following cessation of business operations or the abandonment of the Project if the applicant does not properly decommission the Project and fund full reclamation.

County Counsel

8. INDEMNITY AND HOLD HARMLESS AGREEMENT:

Sun Harvest Solar, LLC has the contracted duty (hereinafter "the duty") to indemnify, defend and hold harmless, County, its Board of Supervisors, officers, employees, agents and assigns from and against any and all claims, petitions, demands, liability, judgments, awards, interest, attorney's fees, costs, experts' fees and expenses of whatsoever kind or nature, at any time arising out of or in any way connected with the performance of this Agreement, whether in tort, contract, writ of mandamus, or otherwise. This duty shall include, but not be limited to, claims, petitions, or the like for bodily injury, property damage, personal injury, contractual damages, writ of mandamus, or otherwise alleged to be caused to any person or entity including, but not limited to employees, agents, commissions, boards, and officers of Sun Harvest Solar, LLC.

Sun Harvest Solar, LLC's liability for indemnity under this Agreement shall apply, regardless of fault, to any acts or omissions, willful misconduct or negligent conduct of any kind, on the part of Sun Harvest Solar, LLC, its agents, subcontractors, employees, boards, and commissions. The duty shall extend to any allegation, claim of liability, or petition, except in circumstances found by a jury or judge to be the sole and legal result of the willful misconduct of County. This duty shall arise at the first claim, petition, or allegation of liability against County. Sun Harvest Solar, LLC will on request and at its expense, defend any action or suit or proceeding arising hereunder. This clause and shall not be limited to any and all claims, petitions, demands, liability, judgments, awards, interest, attorney's fees, costs, experts' fees and expenses of whatsoever kind or nature, that may arise during the term of this Agreement but shall also apply to all such claims and the like after the term of this contract, for example, arising from land use and environmental law actions, or meeting notice law actions, brought against the County following Project approval, modification, or denial.

This clause for indemnification shall be interpreted to the broadest extent permitted by law.

Public Works Department/ Roads Division

 Applicant shall construct a paved rural driveway approach for the proposed access onto San Juan Road or Santa Rita Grade, in accordance with Chapter 7, Driveways, of the Merced County DPW Improvement Standards and Specifications. Said Construction shall require an Encroachment Permit from DPW.

Health Department/ Division of Environmental Health

10. Any hazardous materials stored on-site over threshold quantities (55 gallons, 200 cu. ft. or 500 pounds) requires that a hazardous materials business plan (HMBP) be filed with the Division of Environmental Health. A permit shall be obtained for any portable restrooms provided on the project site.

Public Works Department/ Building and Safety Division

- Applicant shall submit to the County four (4) sets of complete engineered plans and three (3) sets of calculations (or electronic copies) from a licensed architect or engineer.
- 12. A soils report shall be submitted from a licensed geotechnical engineer as part of plan submittal.

San Joaquin Valley Air Pollution Control District

13. The applicant shall comply with District Rule 9510 (Indirect Source Review) prior to issuance of a Building Permit. The applicant shall contact the SJVAPCD to determine if the project is subject to any other district rule

California Department of Fish and Wildlife

 All hollow vertical pipes associated with installation of perimeter fencing and solar mounts shall be capped immediately after installation.

CEQA Mitigation Measures

15. The following is a comprehensive list of CEQA Mitigation Measures applicable to the project and are contained in the Mitigation Monitoring and Reporting Program (MMRP). These measures are incorporated by reference into the Conditions of Approval. The applicant shall be responsible to comply with all Mitigation Measures as referenced herein:

Biological Resources

BIO-1: Mitigate for impacts to Swainson's hawk and nesting birds during construction.

Comment [R1]: Add nesting birds

<u>Cultural Resources</u>

CR-1: Cultural deposits found during ground disturbance requires halt to work and notification to the County.

CR-2: Human remains found during ground disturbance requires halt to work and notification of Merced County.

Geology and Soils

GEO-1: Preparation and submittal of a design level geotechnical report.

<u>Hydrology</u>

HYD-1: Preparation of a Stormwater Pollution Prevention Plan.

Upon motion of Supervisor Kelsey, seconded by Supervisor Davis, duly carried, the Board approves the Mitigation Monitoring and Reporting Program and removes the project site from the Williamson Act Agricultural Preserve.
