#### 10:00 A.M. SCHEDULED ITEM 2016-09-13 PUBLIC OPPORTUNITY

Sheriff Vern Warnke provides an update on Deputy Barba who was injured last week in an incident in Delhi. He states that Deputy Barba came home from the hospital last night and is doing well. He is expected to make a full physical recovery. He thanks the Board for all the support and also for reaching out to Deputy Barba.

Karen Adams, Treasurer/Tax Collector provides an update that the Governor has reinstated the Property Tax Postponement Program. The program provides loans to assist with payment of property taxes on a homeowner's primary residence. She states she is happy that this program has been reinstated, it is beneficial to seniors in our community. She further states that a press release will be coming out soon. She submits a handout on the program for the Board.

Tim Robertson, UDW union staff expresses the union's strong support of IHSS workers. He states that raises for these workers will keep families together and it is a small investment from the County. He also states it's an investment in the people of Merced.

Crystal Mendez, IHSS provider states she provides services for a non-family member, and it is unfair that providers are not making more money. She further states that her client would have to be put in an institution if she was not there to care for him.

Susana Saldana, IHSS provider for her 29 year old son, states her son requires 24/7 care, and states that minimum wage is not enough.

Cynthia Wilson, Madera County UDW member states she has 3 IHSS clients that she cares for, and the Board's decision makes a difference to providers and clients.

Mable Pearson, Madera County UDW member states she is here to support Merced County UDW members. She states that IHSS providers do not receive disability, workers compensation, sick or vacation pay, and requests that the Board consider giving providers a pay raise and benefits.

Javier Alfonso, speaks in support of IHSS and UDW. He states his mother was a client until the end of her life, and requests the Board's support, respect for IHSS, UDW, and the community they serve.

Doris Hughes, IHSS/UDW worker states that UDW has 2,400 members and that their interest is to take care of the most vulnerable citizens in Merced County.

Ashley Zuniga with Stanislaus County UDW speaks in support of Merced UDW members. She states it took 2 years with Stanislaus County Board of Supervisors to get a wage increase. She further states they have an agreement in place for a wage increase over the next 3 years. She requests the Board to please take some of these things into consideration.

A UDW worker states she attended UC Merced and has now decided to become an IHSS worker to care for her parents instead of getting a job. She states it is hard to survive on minimum wage and requests the Board to please think about everyone.

Gloria Sandoval, President of California Journey for Justice speaks about Poverty in the Valley. She states the home health care field is the largest growing sector in American without decent pay. She further states that 90% of the workers are women, and half are people of color with no formal education. She talks about Senate Bill 1015, Home Care Workers Right to extra compensation.

Terri Walker, Stanislaus County IHSS worker states she is here to support the Merced County IHSS workers.

Lydia Rodriquez, Stanislaus County IHSS worker states she is here to support the Merced County IHSS workers and that she is very proud to provide care.

Della Perales, Stanislaus County IHSS worker states she is a provider for her Grandson who is non-verbal and that she is here to support her brothers and sisters here in Merced County.

Matthew Maldonado, UDW representative thanks all the caregivers for coming out today. He states that for every 16 cents that the county gives, the state in turn gives \$1.00. He further states these workers take care of the most vulnerable in our community and that they also save lives.

Supervisor McDaniel states this is a great idea but questions if we are going to offer this to people here in the community before we put it on the internet. He states he knows there is interest out there because constituents have asked him about it.

Mark Cowart, Director of Administrative Services responds and states that we have not made provisions to do so at this time but it is definitely something we can look into doing in the future.

Upon a motion of Supervisor O'Banion, seconded by Supervisor Pedrozo, duly carried, the Board approves declaring miscellaneous office furniture, assorted office equipment and miscellaneous supplies identified (listed on Exhibit A) as Surplus Property as recommended and authorize its disposal by approved internet public auction.
