The Clerk announces item regarding assessments and design of ADA improvements (restroom, paths of travel, etc.) and environmental health issues at Atwater Veterans Hall, Los Banos Veterans Hall, Merced Veterans Hall, and Winton Veterans Hall, and HVAC infrastructure study, design and cost estimate for the Merced Veterans Hall, is before the Board for consideration.

Supervisor Lor requests an oral report from staff.

County Executive Officer James Brown responds that this item is follow up from the final budget meeting. He states that \$1.5 million was set aside to start looking at the Community and Veterans Halls that are most utilized. The recommendation today is to move forward with the plans and specifications for the Atwater, Los Banos, Merced and Winton Veterans Halls. Mr. Brown states staff will come back to the Board with more detailed cost estimates on the projects once received. He further states they will be looking at the HVAC equipment at those facilities as well.

Supervisor Espinoza comments that the Livingston Veterans Hall is in need of more funding and hopes in the future it will be addressed as well.

Supervisor Lor questions the timeline on the project.

Dana Hertfelder, Director of Public Works responds that they hope to have preliminary engineering work done by spring and then come back with cost estimates and seek further direction from the Board to move forward at that time.

Supervisor McDaniel requests clarification on the improvements for each of the halls and if there is a separate source of funds for the Merced Veterans Hall.

Mr. Brown states that at the final budget meeting there was conversation to keep the Merced Veterans Hall HVAC work separate. He further states that the cost estimates may require some budget adjustments.

Upon motion of Supervisor McDaniel, seconded by Supervisor Pareira, duly carried the Board directs the Department of Public Works to complete assessments and design of ADA improvements (restroom, paths of travel, etc.) and environmental health issues at Atwater Veterans Hall, Los Banos Veterans Hall, Merced Veterans Hall, and Winton Veterans Halls, and return to the Board for further direction and to establish necessary capital improvement projects; directs Public Works to complete HVAC assessments of Community and Veterans Halls and other County facilities and develop scope of work and cost estimates, at which time staff will return to the Board for further direction; and directs Public Works to obtain an HVAC infrastructure study, design and cost estimate for the Merced Veterans Hall, and to return to the Board for further direction once the design and cost estimate is known.
