Each speaker will be limited to five (5) minutes.

All proposed agenda items with supportive documents are available for viewing at the Merced County Planning and Community Development Department between the hours of 8:30am and 4:30pm, Monday - Friday (except holidays). This is the same packet that the Planning Commissioners will review and discuss at the Commission meeting. In addition, if you would like a copy of any record related to an item on the agenda, please contact the Department and copies will be provided for the direct cost of duplication or emailed at no cost.

**PUBLIC RECORDS:** As required by Government Code Section 54957.5, any public record distributed to the Planning Commission less than 72 hours prior to this meeting in connection with any agenda item shall be made available for public inspection at the Merced County Administration Building, 2222 M Street, Merced, CA 95340. Public records distributed during the meeting will be available for public inspection at the meeting if prepared by the County. If the public record is prepared by some other person and distributed at the meeting it will be made available for public inspection following the meeting at the Planning and Community Development Department.

**AUDIO/VIDEO BROADCAST:** All Planning Commission meetings are normally broadcast live and replayed on local cable television. **COMMISSION QUORUM AND ACTION:** A Quorum of the Planning Commission shall consist of three (3) members. Actions by the Commission shall require a majority vote (three votes or more) of the total membership of the Commission. When an action by the Planning Commission results in a tie vote the action shall be deemed denied. In the case of a tie vote, the applicant may request that the application be reconsidered at another meeting of the Commission.

**APPEAL NOTICE:** Any person aggrieved by the decision of the Planning Commission may appeal the decision within five (5) calendar days after the day the action is made. [Within ten (10) calendar days after the day the action is made on subdivisions]. The deadline for appeals of Planning Commission actions, excluding subdivisions, is 5:00 p.m. on the Monday following the Planning Commission meeting, and for subdivisions, the deadline is the following Monday at 5:00 pm. Please note that appeals may not be submitted on days that the County is officially closed. Appeals of Planning Commission actions may be filed with the Clerk of the Board of Supervisors. Appeals must state appellant's name, action appealed and reasons for the appeal. A filing fee set by Resolution of the Board of Supervisors must be submitted to the Board Clerk with the written appeal.

You can request a one-day parking pass from County Administration prior to the Commission meeting, which must be displayed on the dashboard of your vehicle.***

V. **PUBLIC HEARING(S)**

- A. **ADMINISTRATIVE APPLICATION No. AA16-005 – Sergio Olide** - To establish an irrigation sales & supply business in an existing 10,850 square foot commercial building. The project site is located on the southwest side of 4th Street, 500 feet south of El Capitan Way. The property is designated Delhi Urban Community - Mixed Use and zoned C-3 (Heavy Commercial). **JB**

**Recommendations: The actions requested are to:**

- 1) Find the project exempt from CEQA review under section 15183 “Projects Consistent with a Community Plan or Zoning” and; section 15301 “Existing Facilities” of the CEQA Guidelines.
- 2) Approve Administrative Permit No. AA16-005 based on the project findings and subject to the recommended conditions of approval presented in the staff report.

- B. CONDITIONAL USE PERMIT APPLICATION No. CUP99-009 – Craven Pit Mine - Jaxon Enterprises, Inc.** – The Craven Pit Mine was approved on May 28, 2008 by the Planning Commission, and affirmed on appeal by the Board of Supervisors on July 22, 2008 to excavate and process approximately 6 million tons of aggregate material from 260,000 tons/year to a maximum 550,000 tons/year, and has been operating since that approval. As a result of violations relating to mining outside of permitted mining boundaries, a hearing is required to approve corrective actions. A stipulated order to comply with conditions of approval, mitigation measures, and the reclamation plan has been prepared detailing the requirements and schedule for the mine operator to correct the violations. The project is located on the east side of White Rock Road and approximately one quarter mile north of Le Grand Road in the Le Grand area. The property is designated Agricultural in the General Plan and zoned A-1 (General Agricultural).

**Recommendation:** The actions requested are to:

- 1) Approve the required stipulated order to correct violations and comply with the conditions of approval, mitigation measures, and the reclamation plan.
