The Board discusses additional traffic analysis and costs. Supervisor Kelsey states initially there was concern on the impact fee costs and questions the contribution costs of the studies by the Riverside Motorsports Project (RMP) based on the estimated traveling car impacts.

Mr. Nicholson advises there is no contribution from RMP for these studies. However, the development fees, improvement fees and costs of the study will be a part of the permit fees and in addition developers will receive a credit for costs previously paid so the costs for the study will equal out for all future builders.

Merced County Farm Bureau Executive Director Diana Westmoreland Pedrozo questions if developers have to pay for road impact fees at the time of development, what fee structure exists and how long it has been in place.

Mr. Nicholson reviews fees collected by Public Works stating they are as follows: New Development Major Bridge and Thoroughfare Fees are in existence and have been for at least 15 years and are updated when a Community Plan is updated; Regional fees through MCAG Regional Transportation Impact Fees (RTIF) and Impact Fees for mining projects and dairies projects for county road truck impacts which are assigned through the discretionary permit processes.
