#### 2008-09-16 AUDITOR

The time and date previously set for a public hearing to consider a Resolution setting the Appropriation Limit for 2008/2009 established under Article XIIIB of the Constitution as submitted by the Auditor.

The Chairman asks if there is anyone present wishing to speak. No one speaks.

The Chairman closes the public hearing.

The Board discusses the population base used for the appropriation limit.

Upon motion of Supervisor O'Banion, seconded by Supervisor Pedrozo, duly carried, the Board approves using the change in population within the incorporated areas of the County as the population factor, and the change in California per capita personal income as the cost of living factor to establish the Fiscal Year 2008-09 Appropriation Limit as \$567,149,477 and adopts Resolution No. 2008-181.

#### ACTION ITEM NO. 9 2008-09-16 SHERIFF

County Executive Officer Dee Tatum reviews the staff report regarding formation of an Agriculture Sheriff's Tactical and Reconnaissance (STAR) Team and advises the Sheriff has provided statistics on the current STAR Team and warrants served and statistics for 2007 and 2008 reported stolen property and arrests.

Assistant County Administrator Jim Brown reviews the Ag STAR options proposals and staffing costs.

The Board discusses the options and the need to provide safety to the citizens of Merced County.

Supervisor Kelsey moves, seconded by Supervisor Pedrozo, the Board authorize forming an Agriculture STAR Team and as provided in Option A - backfill three Deputy Sheriff positions that were previously funded from grants or other revenue and add one Sheriff Sergeant for a total cost of \$442,974 with the matter to return to the Board at Mid-Year for further consideration.

The Board further discusses the outlined options provided in the staff report and the funding of the Agriculture STAR Team.

Supervisor O'Banion states he cannot support the motion and questions the Sheriff's Ag Crime Team utilization is solely for agricultural crime.

CEO Tatum suggests the Sheriff provide statistics to the Board every six months to insure the positions are used for ag crimes only.

Following further discussion, Supervisors Kelsey and Pedrozo agree it is appropriate to take the \$130,648 for the Sergeant position out of the Contingency Fund in order to provide public safety services throughout the County.

Supervisor O'Banion states concern with the next year funding for the positions and feels the Board should have more information before taking action.

Following discussion Supervisor Kelsey moves, seconded by Supervisor Pedrozo, to Amend the Motion on the Floor, to direct the Sheriff to provide a Statistical Report every six months.

Sheriff Mark Pazin responds to Board Members' questions and states a report back will be provided to the Board.

Supervisor O'Banion suggests if the Board selects Option A, have an agreement to start with a base which will indicate whether or not the Ag STAR Team is truly a success and suggests this language be added to the amended motion.

Supervisors Kelsey and Pedrozo agree and Amends the Motion, to reflect the Board authorize forming an Agriculture STAR Team and as provided in Option A - backfill three Deputy Sheriff positions that were previously funded from grants or other revenue and add one Sheriff

Sergeant for a total cost of \$442,974 to begin with a base in place to help determine the success of the Ag STAR Team and direct the Sheriff provide a statistical report every six months.

The Chairman calls for a vote on the Amended Motion. Motion carries.
