# 2016-03-01 HOUSING ELEMENT UPDATE STUDY SESSION

The Clerk announces the Housing Element Study Update Study Session is before the Board for consideration, and there are three Supplementals provided by Community and Economic Development which are available for the public.

Community and Economic Development Director Mark Hendrickson provides an overview of the Housing Element Update. He states that Mintier Harnish will give a powerpoint presentation on the Housing Element Update.

Oksana Newman, Deputy Director of Planning, gives a powerpoint presentation (Supplemental #1) on the Housing Element Update and reviews: Housing Element Overview,

Housing Element Contents, Housing Policies and Programs Overview, Public Participation, Regional Housing Needs Allocation, How will Merced County meet the RHNA?, Existing Capacity, Next Steps, Project Schedule and Questions.

Supervisor Walsh questions if Public Notices were sent to municipalities in our county.

Ms. Newman states they will confirm and provide information to the Board.

Abigail Reyes states she appreciates the analysis work on this project. She speaks regarding AB857, Policy 1.4 of the Proposed Housing Element Change, and insufficient farmworker housing.

Supervisor Pedrozo comments on lack of farmworker housing in Planada, questions the appropriate way to address the issue.

Bill Nicholson, Consultant to the Community and Economic Development Department, states that Planada has Self-Help Enterprises that might be a resource. He states that in the future if land is available, there may be options. Mr. Nicholson spoke about CDBG, Home Funds and rental assistance programs.

Supervisor Kelsey states that there are affordable housing projects she has looked at, and there is funding available. She further states that a private backer is necessary. Supervisor Kelsey uses McFarland, the retired farmworker housing project as an example and states there is lots of opportunity but funding is the key.

Supervisor O'Banion states this is a big issue, and that Self-Help has assisted families in incorporated cities to build homes. States that residents in Dos Palos that utilized Self-Help take good care of their homes.

Supervisor McDaniel states that he was a part of the Housing Element Update meetings and that the mid-level type of housing (rentals, apartments and townhouses) was not addressed in the presentation.

Chelsey Norton Payne, Project Manager with Mintier Harnish, responds and states Supervisor McDaniel is correct, and the housing policy supports a broad range of housing.

Supervisor Walsh agrees with Supervisor Kelsey's comments and states there is a critical need for affordable housing.

Mark Hendrickson, Community and Economic Development Director, states that the next step would be to determine if the Board approves the submittal of the Housing Element Update Draft to California Department of Housing and Community Development for initial review.

Upon motion of Supervisor O'Banion, seconded by Supervisor Pedrozo, duly carried the Board directs staff to submit the Housing Element Update Draft to California Department of Housing and Community Development.
