CONSENT ITEMS # 41 2016-06-28 EXECUTIVE OFFICE

The Clerk announces Amendment Contract No. 2003093 with Merced Defense Associates for Indigent Defense Services for an additional three years is before the Board for consideration.

Supervisor O'Banion states the Board took action in 2015 to go out for an Request for Proposal (RFP) to see if there was anyone else interested in the Indigent Defense contract but was never followed through and today's action is to extend current contract for three more years. Supervisor O'Banion states he will not support additional three years, but he will support 1 year with direction to staff to go out for an RFP to see if there is anyone interested.

Assistant County Executive Officer Scott DeMoss states in 2015, when drafting the RFP, staff reached out to other counties. He further states that Indigent Defense services only have minimal knowledgeable staff in this area and other counties have also had a difficult time finding these services.

County Executive Officer Jim Brown states the Board did authorize an RFP but there was a challenge in finding attorneys, and the costs were significantly greater than the contract before the Board today. Mr. Brown also states that the current provider has stated they were not interested in a one year contract.

Following further discussion on the term of the contract, Supervisor O'Banion moves, seconded by Supervisor McDaniel, to change the contract term to one year and to go out for Request for Proposal to see if there are any other interested contractors.

Chairman Walsh states the courts prefer continuity and the current contract ends this Thursday. Supervisor Walsh also states he will vote "No" on the current motion.

Supervisor O'Banion states he is not saying to do away with the current contract he would like to see an RFP go out.
