<p><b>August 16, 2013</b> E-80</p>	<p><b>Publication</b></p> <p>For <b>Special District Measures</b>, the <b>County Election Official</b> shall publish a public notice including the election date, argument and rebuttal deadlines. <span style="float: right;"><i>EC 9163</i></span></p> <p>For <b>Municipal Measures</b>, the <b>City Clerk</b> shall publish a public notice including the election date, ballot question, and argument and rebuttal deadlines. <span style="float: right;"><i>EC 9205</i></span></p>
