Last Day to File Measure Consolidation August 7, 2015 E-88	Governing Bodies Requesting Measure Consolidation Pursuant to EC 10403, Measure Resolutions are to be submitted to the Board of Supervisors requesting consolidation with this election by E-88; a copy of the resolution is to be provided to the ROV. Resolution to include: Request for ROV to provide services, ballot question (75 word limit), passage requirements, full text (including Tax Rate Statement and Fiscal Impact Report, if applicable). Cities - Impartial Analysis to be filed with resolution. Schools & Districts – County election official will request Analysis. <i>EC 9160, 9222, 9280, 9313, 9500, 10403</i>
August 8 – August 17 E-87 – E-78	10-Day Public Examination Period of Measure <i>EC 9190, 9380, 9286, 9295, 9509</i>
August 12, 2015 E-83	Deadline: Amendment or Withdrawal of Measure The order of election shall be amended or withdrawn upon the filing of a resolution by the governing body stating the specifics concerning the amendment or withdrawal. If the measure is placed on the ballot by the initiative or referendum process, a written withdrawal notice signed by all proponents must be filed with the elections official. <i>EC 9604, 9605</i>
August 12, 2015 E-83	Publication: <ul style="list-style-type: none"> • For County, School and Special District Measures, the County Election Official shall publish a public notice including the election date, argument and rebuttal deadlines. <i>EC 9163, 9502</i> • For Municipal Measures, the City Clerk shall publish a public notice including the election date, ballot question, and argument and rebuttal deadlines. <i>EC 9286, 12102</i>
August 17, 2015 E-78	Deadline: Arguments For or Against <i>GC 57146; EC 9162, 9286(b), 9316, 9502</i>
August 18 – August 27 E-77 – E-68	10-Day Public Examination Period <i>EC 9190, 9380, 9286, 9295, 9509</i>
August 27, 2015 E-68	Deadline: Rebuttals to Arguments For or Against <i>EC 9163, 9167, 9285, 9286, 9316, 9317, 9502, 9504</i>
August 28 - September 8 E-67 – E-57	10-Day Public Examination Period (adjusted for weekend) <i>EC 9190, 9380, 9286, 9295, 9509</i>
November 3, 2015	Election Day <i>EC 1000</i>
